#### ARTICLE I Name

# The name of the corporation is MINGO PIKE CAR CLUB, INC.

# ARTICLE II Purposes and Powers

(A) The corporation is organized and operated exclusively for educational and charitable purposes by any means permitted under the laws of the Commonwealth of Kentucky and under Section 501(c)(3) or corresponding future sections of the Internal Revenue Code.

(B) In furtherance of the general purpose in paragraph (A), the particular purposes of the corporation are to promote, facilitate, coordinate, fund-raise, and provide for the needs of underprivileged youth in and around the Belfry, Kentucky and surrounding areas.

(1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code; or

(2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(D) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes with the meaning of the section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of as described above, shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
