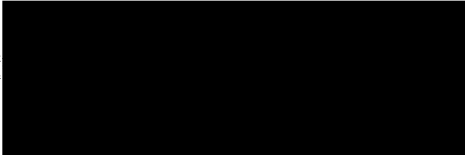

Based upon the Department of Revenue records and the information submitted, **CITY OF STANFORD, KENTUCKY, CITY HALL CORPORATION** is exempt from filing a Kentucky Corporation Income Tax Return pursuant to KRS 141.040, KRS 141.0401 and KRS 136.070.
