ARTICLES OF INCORPORATION

OF

SAVING GRACE COMMUNITY CHURCH, INC.

The undersigned incorporator, Greg Pridemore, after a regular business meeting of the Saving Grace Community Church, was authorized to execute these Articles of Incorporation for the purpose of forming a non-profit, non-stock corporation under and pursuant to the laws of the Commonwealth of Kentucky, and more particularly Chapter 273, Kentucky Revised Statutes, hereby certifies as follows:

ARTICLE I

The name of the corporation shall be Saving Grace Community Church, Inc.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The street address of the initial registered office of the corporation is 8314 Highway 15, Isom, KY 41824. The name of the initial registered agent is Greg Pridemore.

The mailing address of the principal office is 8314 Highway 15, Isom, KY 41824.

The name and address of the incorporator is Greg Pridemore, 8314 Highway 15, Isom, KY 41824.

ARTICLE IV

The corporation is organized and operated exclusively for Christian, charitable, educational and benevolent purposes as described within Section 501 (c) (3) of the Internal Revenue Code (or corresponding provisions of any later Federal tax laws).

Specifically, the purpose of this non-profit corporation shall be to establish and maintain a community church in Letcher County, Kentucky, for the promotion of and instruction in the Christian faith.

ARTICLE V

The names and addresses of the persons who are the initial directors are as follows:

ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VII

The initial By-Laws shall be adopted by the initial Board of Directors. Thereafter, the corporation shall be governed by the By-Laws.

Any director may be removed for cause pursuant to By-Laws provisions regarding grounds and procedures for such removal.

ARTICLE VIII

No director shall be personally liable to the corporation for monetary damages for breach of his duties as a director except for liability:

- (a) For any transaction in which the director's personal financial interest is in conflict with the financial interests of the corporation.
- (b) For acts or omissions not in good faith or which involve intentional misconduct or are known to the director to be a violation of the law; or
- (c) For any transaction from which the director derives an improper personal benefit.

ARTICLE IX

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
