ARTICLES OF INCORPORATION

OF

CUMBERLAND VALLEY CYCLING CLUB, INC.

These Articles of Incorporation are signed by the Incorporator(s) for the purpose of forming a non-profit corporation pursuant to the provisions of the Kentucky Business Corporation Act, KRS Section 273 et seq.

ARTICLE I

The name of the Corporation is CUMBERLAND VALLEY CYCLING CLUB, INC.

ARTICLE II

The purposes for which the Corporation is organized, include, but are not limited to, encouraging bicycling for health, recreation, and transportation; promoting bicycle safety; improving bicycling facilities; furthering all phases of bicycling; and any and all other lawful purposes which the Cumberland Valley Cycling Club, Inc. may deem appropriate, to be conducted in accordance with the by-laws of Cumberland Valley Cycling Club, Inc., to receive, to hold and disburse gifts, bequests and funds for said purposes; to own and maintain suitable real estate and buildings for its purposes; and to do all things necessary and incidental thereto and to conduct any business not prohibited by the Kentucky Non-Profit Corporations Act, KRS 273, et seq. and in accordance with the Internal Revenue Service Rules and Regulations as they apply to non-profit corporations.

ARTICLE III

The Corporation shall have and exercise all powers necessary or convenient to effect any or or all purposes for which the Corporation is organized, including but not limited to the General Powers enumerated in KRS 273.171.

ARTICLE IV

Said organization is organized exclusively for charitable, educational, and scientific purposes, and including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code. Upon the dissolution of the organization, the assets shall be distributed to one or more exempt organizations, including, but not limited to, the Bluegrass Cycling Club, Inc., each of said organizations to be exempt within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE V

The address of the registered office is 300 West Fifth Street, London, Kentucky 40741, and and the name of its registered agent is Drayer B. Spurlock.

ARTICLE VI

The principal office address of the corporation is 300 West Fifth Street, London, Kentucky 40741.

ARTICLE VII

The corporation shall have no capital stock and shall not operate for profit.
